Dear Sanskruti Flat Owners,

Subject: Important Notice from STFOWA regarding Power Disconnection for Defaulters

I hope this letter finds you in good health and spirits. We would like to bring to your attention an important notice from the Sanskruti Township Flat Owners Welfare Association (STFOWA).

STFOWA has made a decision that starting from this month, power supply will be disconnected to defaulters every month if the outstanding dues are more than Rs. 25,000. This decision has been taken to ensure that all flat owners in the Sanskruti Township clear their dues in a timely manner and to prevent any further accumulation of pending dues.

Please note that the disconnection schedule is as follows:

A01 to A16: 16th of every month

AB17 to A33: 18th of every month

A34 to A50: 20th of every month

C01 to D04: 22nd of every month

We request you to kindly ensure that all your outstanding dues are cleared before the due date of each month to avoid any inconvenience caused by the disconnection of the power supply. We also urge you to monitor your monthly dues regularly and make timely payments to avoid any penalties or disconnections.
